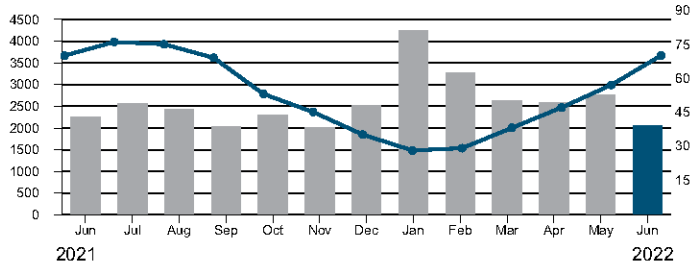

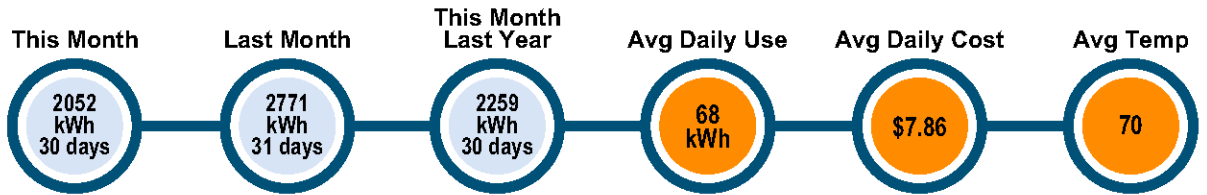

# Your Electric Bill

**1** This indicates the **amount of and due date for current charges**. If payment is not received by this date, a past due notice is mailed and service is subject to disconnect.

**2** Your **balance summary** shows your previous payments, current balance, and the total amount due by the current bill's due date.

**3** Detach this stub and include it with your payment when sending it by mail or bring it with you to pay in person at our office.

**4** Payments can also be made over the phone and online. MCREA encourages our members to sign up for **SmartHub**, our web and mobile app. With SmartHub, you can make payments, track your usage, and receive outage notifications.

**5** This is the number of your **rate class**. Visit [www.mcrea.org/tariff-sheets](http://www.mcrea.org/tariff-sheets) to see all rate classes and corresponding tariff sheets.

**6** This number is your **meter number**. It is linked in our office with your location. When reporting a power outage or service problems, this number is most helpful to our dispatcher and line crews.

**7** **Charges** - The **Facility Charge** is the monthly base amount charged for providing electric service. It includes costs of meter reading, billing, administrative overhead, maintenance and repair of system poles, lines, transformers, meters, etc. These have been itemized per member account. The **Energy Charge per kWh Rate** denotes the cost of purchasing our power from our provider, Tri-State Generation & Transmission, and distribution of electricity from MCREA's substations to your home or business.

**8** The **Energy Usage Comparison** provides more information about how electricity is used at that location. It also provides other details, such as average temperature that month.
